



## Fact sheet for SMP traineeships abroad with ERASMUS+ (2022 project) (for traineeships from February 2022 – October 2023)

Target group: students and graduates from all subjects at HHU

1. Basic information	<ul style="list-style-type: none"> <li>Enrolment at HHU throughout the traineeship period (for students) or enrolment at the time of application (for graduates); the traineeship must be undertaken and completed within one year of finishing your studies)</li> <li>Confirmation of a traineeship you have organised yourself at a private or public employer in a European country participating in the Erasmus programme. We cannot fund traineeships at EU institutions</li> <li>Scope: Full-time traineeships of <b>at least 30 working hours per week</b></li> <li><u>Minimum duration</u>: 2 months or <b>60 days</b> (1 funding month corresponds to exactly 30 days, e.g.: 1 July – 31 August 2020 = 2 Erasmus months = 60 days; if the traineeship ends in February, this month will only be counted as 28 or 29 days)</li> <li><u>Maximum duration</u>: 12 months</li> <li><u>Maximum period for an individual traineeship for which HHU will provide funding</u>: <b>180 days</b> (= 6 months)</li> <li><u>Maximum funding period per degree (bachelor's, master's, doctorate)</u>: 12 months (all traineeship stays and study periods abroad added together)</li> </ul>

Documents for the application process	<ul style="list-style-type: none"> <li>Online application (see homepage)</li> <li>Confirmation of traineeship e-mail in German or English</li> <li>Covering letter (max. 1 page)</li> <li>Certificate of enrolment</li> <li>Transcript of Records dated in the current month</li> </ul>
4. Documents for grant recipients	<ul style="list-style-type: none"> <li><b>Original</b> Grant Agreement with your handwritten signature (will also be sent by e-mail)</li> <li>Learning Agreement for Traineeships with signatures (submit as a PDF document) (will also be sent by e-mail)</li> <li>Where applicable: Social Top-Up application by e-mail and <b>original</b> Green Travel application</li> <li>OLS (Online Linguistic Support) language test (once available)</li> <li>Confirmation from your subject of the options for recognition of the traineeship; for medical students: extract from the list published by the State Examination Office for Medicine, Psychotherapy and Pharmacy (<i>Landesprüfungsamt für Medizin, Psychotherapie und Pharmazie</i> – LPA)</li> </ul> <p style="color: red; text-align: center;">+++++ Please see the checklist for detailed information (will also be sent by e-mail) +++++</p>
5. Final documents	<ul style="list-style-type: none"> <li>Traineeship Certificate (<b>original version with handwritten signatures</b>)</li> <li>Experience report (upload to MoveON)</li> <li>OLS language test (once available)</li> <li>EU Survey (once available) – you will receive an automatic e-mail</li> </ul>
6. Conditions for receipt of the funding	<ul style="list-style-type: none"> <li>On-time submission of the application</li> <li>Completeness of the application documents</li> <li>Minimum duration of stay achieved</li> </ul> <p>➔ If the available funds are insufficient to support all applicants, the applications will be evaluated on a subject-specific basis in the individual faculties with reference to defined selection criteria. You can find these criteria on the website under <b>Erasmus traineeship</b> and on the websites of the subjects.</p>
7. Grants and additional payments	<ul style="list-style-type: none"> <li>A confirmation usually includes a grant</li> <li>The grant comprises a financial allowance calculated on the basis of the exact number of days</li> <li>Once you have submitted all the application documents, you will receive 80% of the funding and the remaining 20% will follow after submission of the final documents</li> </ul> <p>➔ Please visit our homepage to find out about <b>Green Travel</b> and <b>Social Top-Ups</b>. We will also send you the corresponding forms via e-mail.</p>
